Stated the tax cap is 1.56% for 2021, last year was 2.00%. \* \$3,500 in spending would raise taxes by 1%. \* Last year the courts took in \$35,000, this year to date, they took in \$4,000 due to the COVID. It is not known if we will get money from Extreme NY, Pave NY or AIM funding due to the COVID. Long term effects of the COVID to our budget could be devastating. \* The following are increases and decreases for the 2021 budget that I have put together for review. \*Highway Superintendent Ackley is not here tonight so we are not able to go over highway.
